

The County of Mercer requests bids for Inmate Supplies for use by the Mercer County Correction Center. The County reserves the right to award multiple contracts based upon the total in each section (i.e. boots shall be awarded to one vendor based upon the total cost for boots). **PLEASE REFER TO THE UNIT OF MEASURE, I.E. EACH, PAIR OR DOZEN FOR EACH CATEGORY AND SUBMIT PRICING BASED UPON THAT UNIT OF MEASURE.**

TERM OF CONTRACT

Contract shall be awarded for a two (2) year period.

UNIT COSTS
