



**SPECIFICATIONS FOR REBID OF CLOTHING AND FOOTWEAR
FOR ALL COUNTY AGENCIES AND THE MERCER COUNTY
COOPERATIVE CONTRACT PURCHASING SYSTEM FOR A PERIOD OF TWO (2)
YEARS**

PURPOSE AND INTENT

This Request for Bid is issued by the Department of Purchasing on behalf of All County Departments and Agencies. The purpose of this rebid is due to Rejection No. 2018-278 of Bids received December 12, 2017 for Clothing and Footwear is to solicit bid proposals for Clothing, Outerwear, and Footwear. The intent of this RFB is to award one contract for a period of two years to those responsible bidders whose bid proposal conform to this RFB. **The county currently has in place, contracts for officer's uniforms for the Correction Center, Sheriff's Department and Prosecutor's Office.**

BIDDERS MUST BE AUTHORIZED DISTRIBUTORS FOR EACH MANUFACTURER'S CATALOG SUBMITTED FOR BID.

Contracts shall be awarded to the lowest vendor who can supply all items to departments based upon the wholesale rate for 2018 and subsequent catalogs for 2019 and 2020. However, if the lowest vendor is unable to supply items needed the county will proceed to the next lowest vendor. The award shall apply to all 2018 catalogs supplied by the vendor in this bid as well as future product releases. Electronic catalogs should be made available for future product releases. Vendors must be **authorized** distributors for each manufacturer's catalog submitted for bid. Bidders shall provide catalogs including but not limited to the referenced brands or equivalent.

TIME FOR DELIVERY

Delivery shall be made within two weeks for standard items that do not require embroidery. Delivery shall be made within three weeks for standard items that **require embroidery. In all cases, delivery shall be made within three weeks.**

In the event of a manufacturer's price decrease during the contract period, the County shall receive the full benefit of such price reduction.

CLOTHING & FOOTWEAR (CLOTHING MAY REQUIRE EMBROIDERY)

Bidders shall provide pricing for application of county patches. The County may supply emblems; however the vendor shall also provide emblems.

The County will accept the following catalogs or equivalent catalogs that respondent's are authorized by the manufacturer to sell: Redwing, Wolverine, Dickie's Brand, Berne Apparel, Carhartt, Rocky Shoe and Boots, Red Kap, Timberland, Bates, Workrite.

Vendors shall provide pricing for furnishing embroidered patches or emblems. Refer to the County, Trenton-Mercer Airport and Park Commission logos.

METHOD OF BIDDING

The bidder must submit with its bid proposal the manufacturer's official price list or most recent catalog. The bidders shall be authorized distributors of each brand bid upon. The price list submitted must be the current Cost Price List representing the cost price. The bidder's failure to submit the MANUFACTURER'S OFFICIAL PRICE LIST (S) or CATALOG will be cause for rejection of the brand in question. Bidders must submit the most current published catalog with the bid proposal. The catalog must show the products being bid. Only those items for which the Department of Purchasing has received the applicable catalog and price list will be considered for award.

The bidder must indicate a percentage markup on the "Price Sheet" portion of the RFB. Only one percentage markup per line item/brand will be accepted. Multiple or series discounts will be not accepted. Markup percentage is not to be extended beyond two decimal places. All prices and markups are based on the Cost Price. Products bid with incorrect Cost Price Lists will be rejected. The award shall be based upon the same Manufacturer's Cost Price List for all bidders. Therefore, it is essential that the bidder comply with the requirements set forth in this RFB. No exceptions will be made.

Official Price Lists are to be in effect prior to the bid opening date of this RFB. If a manufacturer's catalog also serves as its price list, then a separate price list is not necessary. The bidder may submit a combination catalog/price list as the Official Price List.

Successful contractors shall furnish, upon request, at any time during the term of the contract, both awarded price lists and catalogs to the using agencies at no additional cost.

SAMPLES

Samples are not required with the bid. Prior to award, samples may be requested. Such samples must be furnished within ten working days of written request by the County. Failure to submit samples in the timeframe requested will result in the rejection of your bid or contract.

Samples must be submitted free of charge and are non-returnable due to testing procedures. All samples are subject to tests in the manner and place designated by the Agency.

EMBROIDERY/LOGO ITEMS

Each vendor shall provide a cost for digitization, embroidery/logo and a price list per items that may be emblazoned with the County of Mercer, Trenton-Mercer Airport or Mercer County Park Commission logo.
