Prospectus

Juror: Anita Allyn

Anita Allyn is Associate Professor of Art at The College of New Jersey, where she has taught since 1999. With a MFA from The School of the Museum of Fine Arts, Boston, and a BFA from The Kansas City Art Institute, she is an interdisciplinary artist whose works combine photography, video, animation, and print. Her work is compelled by media culture and its numerous manipulations and permutations. Her approach to media investigates temporality, cultural memory, and engages the media landscape through myriad strategies and codifying systems. Allyn's work has been exhibited at such venues as The Tate Modern, London; National Centre for Contemporary Arts, Moscow; International Photography Biennial, Columbia; as well as in local venues at the University of Pennsylvania, Vox Populi, in Philadelphia, Art Institute of Boston, Atlantic Center for the Arts, and the Museum of Fine Arts, Boston.

Eligibility

Open to all artists, eighteen years or older, currently living, attending school, or employed in Mercer County. Images must have been created within the past three years utilizing photographic processes including black and white photography, color photography, non-silver processes, book art, and computer processed photography. Work must be appropriately presented for gallery installation. Two-dimensional work must be framed and properly wired for hanging.

Entry Procedures

All work must be delivered by hand to the Silva Gallery of Art in the Campus Center building on the campus of The Pennington School, 112 W. Delaware Ave., Pennington, New Jersey on October 21 between 9:30 a.m. and 12:00 noon. Unaccepted work must be retrieved by 5:00 p.m. on October 21, no exceptions. Works selected for the exhibition will be insured against damage and theft while on exhibit at the Silva Gallery. Work not claimed by noon on December 9 becomes property of The Pennington School.

Entry Fee

Entry fee is \$10 for each entry, up to two entries per individual, payable in cash or check made out to The Pennington School. Please write Silva Gallery on the memo line of checks. The Silva Gallery receives 25% percent commission of all sales and donates all proceeds to the School's annual fund. Work does not need to be for sale to be entered.

Reproduction Rights

Submission of entries acknowledges the right of the Silva Gallery of Art at The Pennington School and the County of Mercer to reproduce all or part of an entry to publicize and otherwise promote the exhibit, artists, events, and venue.

Awards

Monetary and merit awards include: Best in Show, Juror's Choice, Honorable Mentions, and Mercer County Purchase Awards.
